NARRATIVE: 1. ON 10/14/02 @ APPROXIMATELY 2029 HRS. UNIT #3 WAS TALKING TO OFF DUTY DEPUTY JOE DOMINGUEZ AT THE MASON YOUTH CENTER. UNIT #3 WAS CONTACTED BY A FEMALE COUNSELOR FROM ON TRACK VIA RADIO ON THE PRIMARY MASON COUNTY SHERIFFS OFFICE DISPATCH CHANNEL.

2. UPON THE FIRST CONTACT UNIT #3 WAS UNSURE OF WHO WAS ON THE RADIO. UNIT #3 MADE CONTACT WITH DISPATCH AND ASKED, " MASON, DO YOU HAVE TRAFFIC FOR ME?" UNIT #3 WAS AGAIN CONTACTED BY THE FEMALE. THE FEMALE STATED IN A TREMBLING VOICE, " THIS IS ON TRACK, WE NEED AN OFFICER OUT HERE RIGHT AWAY!" .. " WE HAVE A RESTRAINED JUVENILE OUT HERE, AND WE NEED AN OFFICER RIGHT AWAY!"

3. THE FEMALE SOUNDED AS IF SHE WAS A LITTLE OUT OF BREATH, AND SCARED. UNIT #3 ASKED (ON THE RADIO) " CAN YOU GIVE ME SOME MORE INFORMATION?" THE FEMALE STATED THAT THE RESTRAINED, MALE, JUVENILE, HAD BECOME PHYSICALLY COMBATIVE, AND HAD MADE RACIAL SLURS TOWARD THE OTHER COUNCELORS. UNIT #3 ADVISED DISPATCH THAT HE WAS ENROUTE. UNIT #3 ADVISED THE FEMALE AT ONTRACK, " WHEN I GET IN THE AREA I WILL NEED DIRECTIONS TO THE EXACT LOCATION." THE FEMALE ADVISED, "WE ARE AT CAMP ELIZABETH, SPRINGER PASTURE."

4. THE FEMALE ASKED MASON DISPATCH TO GET IN TOUCH WITH T. WAYNE SCHWERTNER WITH TEXAS PARKS AND WILDLIFE, AND A COUPLE OF OTHER NAMES THAT I WAS NOT FAMILIAR WITH.
